Professor Steven Boyages

Professor Steven Boyages has recently been appointed as Chief Executive of the newly formed Clinical Education and Training Institute (CETI). Prior to this Professor Boyages was the Chief Executive initially for Western Sydney Area Health Service and in the last 5 ½ years as Chief Executive for Sydney West Area Health Service. He has professorial appointments to the University of Sydney and the University of Western Sydney.
