## Building Toward a National eHealth Future

Australia has a rich history of endeavour and innovation in electronic health including the electronic delivery of clinical transactions and the creation of electronic health records. Recent government investments have seen the growth of national infrastructure to provide a common support network for a variety of clinical, research, and reporting purposes.

As electronic health is adopted and incorporated into clinical practice, equipping health professionals to understand and work with the information systems put in place will provide many benefits to both the health professionals and patients.

NEHTA's purpose is to lead the uptake of e-health systems of national significance; and coordinate the progression and accelerate the adoption of e-health by delivering urgently needed integration infrastructure and standards for health information

This session will outline the case for and provide further discussion on eHealth services including an overview of the Personally Controlled Electronic Health Record (PCEHR) system and describe proposed mechanisms required to support a connected future.. This session will also explore a number of these benefits and include a demonstration of an information system
