Executive Summary

This paper is written as part of an Australian national project to encourage a coordinated interprofessional approach to curriculum renewal for eHealth capability in clinical health professional degrees. The aim of this project is to initiate and encourage the inclusion of eHealth capability and competencies within entry level health profession degrees. We therefore, surveyed, interviewed and conducted workshops with academic coordinators and directors of health profession coursework degrees across Australian universities, including allied health, nursing and medical professions.

This project has already produced several resources; a literature review on the work undertaken nationally and internationally with regard to the learning, teaching and assessment of eHealth in health profession degrees, a review of Australian accreditation guidelines for health profession degrees and discussion papers based on the data collected from surveys, interviews and four national workshops.

The aim of this paper is to add to this resource pool by providing an inventory of resources that can be used for teaching of eHealth to entry level health profession students. In addition to supporting teaching, these resources can also assist staff in keeping up to date with current developments in eHealth. It could be used by advanced level coursework and research students who are interested in exploring topics related to eHealth. This document can also be used to establish collaborations and contacts with the resource providers.

The resources were found by performing a search via Google. Some search terms that were used were quite broad whilst others specific to eHealth. For a list of the search terms, please refer to Appendix A.

The draft document was circulated amongst selected expert educators for feedback and comments.

The resources have been sorted by name of Author. Other information provided for each resource include:

- Provider type for example, university, government etc.
- Type of Media for example, Powerpoint presentation, video etc.
- Description/web address a brief description of the resource as well as the web address.

The list of resources is not exhaustive, and contains Australian as well as international references that are relevant to Australian educators. The references provided were up to date as of September 2012.
